“Spring Clean-up To Begin on April 5, 2010”

GARDEN CITY – The City of Garden City will be conducting its 2010 Spring Clean-up program from April 5 through April 16. This free pick up service is intended for residential areas only. To accommodate the needs of residents as well as the City collection crews, the City has been divided into eight collection areas to be addressed throughout the clean up period.

- **April 5** – The area north of Kansas Ave. to south of Mary St. between Fleming St. and By-Pass, and north of Mary St. to north City Limits between Main St. and By-Pass.
- **April 6** – North of the drainage ditch to north City Limits between the Hager Addition and Main St.
- **April 7** – North of Kansas Ave. to south of Mary St. between Main St. and Fleming St.
- **April 8** – North of Kansas Ave. to the drainage ditch between Taylor Ave. and Main St.
- **April 12** – South City Limits to Fulton St. between Taylor Ave. and Center St.; south City Limits to Kansas Ave. between Center St. and Jennie Barker Rd., and Prairie Wind Subdivision.
- **April 13** – North of Fulton St. to south of Kansas Ave. between Main St. and Center St.
- **April 14** – North of Fulton St. to south of Kansas Ave. between Main St. and Taylor St.

- **April 15** – North of Fulton St. to south of Campbell St. between west City Limits and south City Limits.

Friday, April 9 and Friday, April 16 will be used as general collection days in order to give adequate coverage to those areas that may not have been completed during scheduled collection days. For those individuals who may have been missed during their regular collection day, please call 276-1270 before Thursday, April 15 to make arrangements to have your items collected.

Public Works is coordinating this program and due to landfill regulations and other logistical requirements asks residents to follow the guidelines below:

- No commercial users allowed
- All items to be picked must be placed by the street curb; no alley pick-ups will be conducted
- Do not place debris on water meters
- Please separate tree trimmings into one pile, old furniture and boxes into another, and old appliances into another
- We are unable to pick up refrigerators and air conditioners unless arrangements are made with the Street Department
- We can pick up tree trimmings as long as they are no longer than 8 feet in length.
- One truckload of tree branches/brush per home
- Grass clippings will not be permitted
- Liquid paints and petroleum products (oil, roofing tar, crack sealer, gas, diesel etc.) are not permitted
- Vehicle motors and batteries are not permitted

- Any waste created by a contractor for tree trimming, home remodeling, appliances, etc. will not be accepted. The contractor is responsible for the removal of these items.
